Teaching resources to use with 9-12 year olds – Just a joke- sexualised online bullying This toolkit explores problematic online sexual behaviour, with a focus on online sexual harassment e.g. bullying or harmful behaviour online based on gender or sexual orientation stereotypes, body-shaming, nudity and sexually explicit content.

In resources that are used or seen by children, they use the term 'cyberbullying' and refer to the specific type - cyberbullying that uses gender stereotypes, body shaming or nude images. This is because they know the words 'sexual' and 'harassment' may not be understood, used or appropriate for 9-12 year olds.

Step Up, Speak Up! Teaching Toolkit for 13-17 year olds.

Practical, interactive and scenario-based resource which addresses the issue of online sexual harassment amongst 13-17 year olds. The toolkit is comprised of 4 lesson plans with accompanying films, an audio story, workshops and an assembly presentation. Defined as 'unwanted sexual conduct on any online platform', online sexual harassment amongst young people has been an increasingly present issue in schools and local communities. These freely available resources aim to:

- Increase awareness and understanding on peer-on-peer online sexual harassment
- Address responses to those targeted, including tackling victim-blaming culture
- Call on young people to report if they see it happening online
