## **2024 GROWING UP IN NORTH YORKSHIRE SURVEY - SUMMER TERM 2024**

**There is no cost to the school and the survey is available for all state funded schools and academies in North Yorkshire.**

The North Yorkshire Children and Young People's Service (CYPS), Public Health and North Yorkshire Police have again commissioned a survey of children and young people covering aspects of learning, safeguarding and well-being, to take place in the summer term 2024. The survey will continue to provide key information about the learning, safety and wellbeing of children and young people across Years 2, 6, 8, 10 and 12, in mainstream schools and in special schools and PRUs. The outcomes from the survey can be used to inform schools self-evaluation and planning as well as the strategic planning for the Children and Young People's Service and partners. Participation in this survey hugely supports our understanding of children and young people's wellbeing and any safeguarding-related issues across the whole of North Yorkshire.

The majority of North Yorkshire primary and secondary schools, covering over 17,000 children and young people, participated in the 2022 Growing up in North Yorkshire Survey. Information gained from individual school and county level analysis provided knowledge and understanding about the wellbeing, lifestyles and learning of children and young people and influenced school, locality and county planning and evaluation of provision. As the survey has now been running for 18 years it provides us with a wealth of trend data which enables the funding of many projects to support the wellbeing of children and young people across the county.

Every school that participates receives their own individual school report with the data from their pupils alongside comparative data with the North Yorkshire averages for each question. Schools and partners can also access the North Yorkshire County and Locality Reports to support them with further identification of key priorities. The 2022 and 2020 reports are available [here](#)

Recent feedback from schools who participated in the GUNY 2022 survey about the benefits of participating include:

- *“Understanding our students better; a confidential forum to elicit reliable information”*
- *“Additional information and student voice that we would otherwise not have”*
- *“To support identification of contextual safeguarding”*
- *“Useful information about our pupils and helpful comparisons to others and larger cohorts”*
- *“A reliable source of data to inform planning re: PSHCE and Safeguarding and valuable information to support school development”*

Due to feedback from schools, we have made some changes to the survey with a focus on making the surveys shorter for all age groups with a particular focus on the Year 2 survey and ensuring it is accessible for that age group.

The survey methodology continues to be through school based questionnaires developed by the Schools’ Health Education Unit (SHEU) in close consultation with the North Yorkshire Children and Young People’s Service. I am keen that all schools participate in the survey and very much hope that after reading the details, you will feel that you will take up this positive opportunity for your school to participate in the 2024 Growing up in North Yorkshire Survey. I hope that the benefits for your school in terms of safeguarding children and young people and the evaluation across a broad range of pupils’ personal and social development as well as supporting your school with school improvement, Ofsted requirements, curriculum planning and target setting will encourage you to participate in the 2024 survey.

## Key Supporting information for the 2024 Growing Up in North Yorkshire Survey

Five questionnaires are available, free of charge, for all stated funded and academies in North Yorkshire schools

For primary schools the questionnaires will be offered as online versions. This will enable a swifter return of data to schools and for many schools is a preferred way of conducting the surveys. We appreciate this may require some planning to enable pupils to be able to access the technology so they can complete the questionnaires. Schools will be able to immediately access the raw data. Due to feedback from the 2022 survey the questionnaires have been shortened and made more accessible for the Year 2 pupils.

Arrangements and instructions to access the online survey will be sent directly to schools to the named email contact provided when signing up to participate in the survey. For secondary schools that request paper copies of the questionnaire and special schools these will be sent and collected by courier for delivery to the SHEU, Exeter.

Key Stage 1 questionnaire (Y2 and Y3 for schools with fewer than 30 Y2 pupils)	Online survey only
Key Stage 2 questionnaire (Y6 pupils and Y5 for schools with fewer than 30 Y6 pupils)	Online survey only
<b>Secondary schools with a sixth form are encouraged to enable Y8, 10 and 12 pupils (where applicable) to participate in the survey</b>	
Secondary questionnaire (including PRS) (Y8 and Y10 and Y 12)	Online survey and paper version available
Secondary questionnaire for Sixth Form Colleges (Y12)	Online survey
<b>Special schools are encouraged to enable all pupils who are able to access the questions to participate (guidance is provided for some of the questions)</b>	
SEND questionnaire (Special school/ PRS only)	Paper version only

**Small primary schools** will receive their own school report provided there is a minimum of 7 pupils participating across the school (to protect pupil confidentiality). For very small primary schools who would not meet this requirement, Year 4/5 pupils may also participate in the Key Stage 2 questionnaire, but may need support to access the questions (schools may also want to consider the appropriateness of some questions for younger pupils). We will continue to offer our smallest schools the opportunity to have a joint school report with a partner school, to enable our smallest schools to participate whilst securing the anonymity of pupils.

### Outcomes and use of data

The outcomes will be a set of countywide data at key points in children and young people's development.

Schools and Commissioning Authorities receive summaries of the processed data. CYPS will receive data at county and locality level and reports from each school. The results from your school will only be shared within agreed data sharing protocols. Where comparative analysis is thought desirable schools will only be identified by a code, not by name. Schools will receive their school report, and of course schools are free to share their own data with colleagues, governors, pupils, parents/carers and the wider community including other local organisations who can offer support.

### **Arrangements to participate**

If you wish your school to participate in the 2024 survey, we will need the following arrangements to be made:

- A member of staff to be nominated to manage and supervise the questionnaire
- **To allocate up to 70 minutes of lesson time, between 16th April -24th May 2024 for pupils in your school to complete the questionnaire.** The session must include an introduction and time for questions and for all pupils to be reminded that the questionnaire is anonymous so if it raises any issues or concerns for them where to find support within school. Adequate time and supported exam conditions are essential. The questionnaire should not be sent home with pupils to complete it must be completed on the school site.
- The questionnaire can be completed any day of the week EXCEPT a Monday (some questions are about 'yesterday') and not during a week following a school holiday (some questions are about 'last week')

### **Updating of questionnaires for 2024**

It is not intended that there are significant changes to the 2024 questionnaires to enable benchmarking against 2022 data, though feedback from schools and partners has been considered in order to ensure that the survey is as informative as possible. All questionnaires have been shortened and the Year 2 survey has been made more accessible for this age group.
